

Standard Terms and Conditions of Sale of Just Eyewear (Pty) Ltd

1. Right of Ownership
 - a. Ownerships of all goods sold by Just Eyewear only passes to the purchasers once all amounts outstanding for the goods sold are paid for in full.
 - b. Just Eyewear (Pty) Ltd shall have the right, at its sole discretion, to repossess/demand return of goods not paid for as agreed upon in the "Payment Terms" listed below.
 - c. Notwithstanding the aforementioned, the total risk and responsibility in and to the goods shall pass to the purchaser on the date of delivery.
2. Payment Terms
 - a. Standard settlement terms are 30 calendar days from date of Statement.
 - b. 15% Settlement Discount for payments within 30 calendar days of statement.
 - c. Payments made after 30 calendar days will not qualify for the settlement discount unless agreed to by the Sales Director of Just Eyewear.
 - d. All accounts older than 90 Days will be placed on hold and handed over to our duly appointed legal representation for collection.
 - e. An account may not withhold payment of any invoice if there is a disputed that may exist on another invoice.
 - f. PLEASE NOTE: If a remittance is not received with a payment the amount received will be deducted from the longest outstanding invoice(s).
3. Credit Terms
 - a. All accounts will be set applicable Credit Terms.
 - b. Regrettably we will have to suspend all deliveries of orders in cases where the credit terms have been exceeded.
 - c. Deliveries of orders will commence once all outstanding amounts have been settled in full.
 - d. We further reserve the right to charge interest at the prevailing prescribed rate as per The Usury Act.
4. Distribution
 - a. Orders are delivered within our normal areas of delivery by means of our own transport.
 - b. Unless agreed otherwise by the management of Just Eyewear all associated delivery costs will be for the account of the purchaser.
 - c. The purchaser agrees that no products purchased from Just Eyewear (Pty) Ltd will be exported or sold to areas outside of South Africa.
 - d. Just Eyewear (Pty) Ltd will not be liable for any loss or damage whatsoever suffered by the purchaser due to a delivery date or times not being met for whatever reason and the purchaser hereby indemnifies Just Eyewear (Pty) Ltd from any such loss, damages and claims.
 - e. The signature of any employee or agent of the Purchaser on Just Eyewear's delivery note, POD Document, waybill or invoice or that of the carrier will constitute conclusive evidence of receipt of the goods by the Purchaser.

5. Return for Credit

- a. Arrangements to return goods for credit in circumstances that are not related to distribution errors or warranty claims must be handled with the product representative directly who will act with the consent of the Sales Director. All arrangements must be made before goods are returned.
- b. A Goods Return Note (GRN) must be handed to you by the product representative and the corresponding number must be quoted at all times when discussing the return.
- c. All products must be returned in the original packaging and in a saleable condition to qualify for credit.
- d. No goods purchased that are older than six months may be returned for credit.
- e. Discontinued and discounted products will not be accepted as returns.
- f. Unauthorised goods returned will be sent back to the sender at the sender's expense
- g. Relevant invoice numbers as well as GRN numbers must accompany all returns.
- h. All settlement discounts passed onto the account for the products will be recouped from the account as these goods have been returned and therefore forfeited the settlement discount.

6. Claims

- a. All products are fully guaranteed against any manufacturer's defects. Any defective part will either be replaced or repaired at the discretion of Just Eyewear (Pty) Ltd.
- b. As of the 1st of September 2022 our new **two year warranty** policy is in effect and applicable across all current brands.
- c. All claims for breakages, damages and short-deliveries need to be made within 10 working days of receipt of the goods.
- d. Individual manufacturer's warranties will be administered according to the terms of the warranty.

The above terms and conditions of sale apply to all sales made by Just Eyewear and may only be modified with the written consent of a Director.
